Initial	<p>I am participating in the Just Between Friends Consignment Sales Event as a Consignor/Team Member. I understand and accept that Just Between Friends is not responsible for fire, loss, theft or damage to my items. I understand that I will be charged 35% of my gross sales, less a Consignor Fee for participation: <b>\$15</b> for all consignors and <b>\$20</b> for consignors who indicate on this form that they will pick up unsold items but do not.</p> <p>I understand that Consignors who also are a Team Member-participant for a minimum of 4 hours before, during or after the sale will be charged only 30% of his/her gross sales.</p>
Initial	<p>Consignor <b>Pick Up</b> (of any unsold items) is <b>Sunday, from 8pm to 9pm</b>. I understand that any items not picked up <b>before 9pm</b> will be donated to the JBF Charity Partner. Please <b>NO CHILDREN</b> at Drop Off or Pick Up.</p>
Initial	<p>Items that are stained, broken, dirty, recalled, missing pieces or missing batteries will be declined at Drop Off and returned to consignor at pick-up on Sunday. Items declined during inspection marked "donate" will be donated.</p> <p>JBF reserves the right to remove unacceptable items from the sales floor throughout the sale.</p>
Initial	<p>I understand that as a condition of selling items in a Just Between Friends Consignment Sale, I represent the following to be true and correct:</p> <ol style="list-style-type: none"> <li>1. I am the owner of the items to be sold and I have full authority to sell the items offered by me for sale; and</li> <li>2. Each item offered for sale by me is in good operating condition, reasonable wear and tear accepted, and is not broken or damaged in any way; and</li> <li>3. Any repaired item was repaired by the original manufacturer or in accordance with the original manufacturer's warranty program; and</li> <li>4. Each item complies with applicable law, <a href="https://www.cpsc.gov/cpsclist.aspx">https://www.cpsc.gov/cpsclist.aspx</a>; and</li> <li>5. No item is the subject of any pending or threatened recall notice or other consumer protection enforcement action; and</li> <li>6. I know of no reason why any item offered for sale by me would cause injury to another.</li> </ol>
Initial	<p>A "star" printed on JBF tags means that the item will remain at FULL PRICE throughout the sale. Tags with no star means the item will be sold 50% off on the last day of the sale (or at 25% off on the day prior to the 50% off day if an extra day is added to the event). For consignors' protection, alterations to the tags (lowering/increasing price or adding/removing a star), WILL NOT be accepted any time during the sale. The Barcode is the deciding factor for any variation on a tag.</p>
Initial	<p>I am participating for the sole purpose of selling my items as a consignor. <b>I am participating in an ethical manner, and agree that I am not attempting to learn the business practices of JBF, operations techniques or any other business matters that may or may not be trademarks, registered or proprietary in any way to start my own competing sale.</b> I am willing to sign a confidentiality agreement and will do so if asked by a representative of Just Between Friends.</p>
Initial	<p>If I am a Team Member-participant (allowing me to shop early and earn an extra 5% on my sold items = 70%), I will be ready to participate for the full time I've reserved. If I am unable to do so, I will find a replacement and let JBF know by TEXTING 971.273.6990! I will also check-in and check-out at the Volunteer-Participant Table.</p>
